GDPR: "Data generated by connected vehicles or machines may be considered personal data as it can be directly or indirectly linked to Operators or even third parties".

Key: "Anonymisation"

"Once data is fully anonymised, European legislation (GDPR) no longer applies".

We all know the use case of GPS data in mobile phones.

Anonymized data has been used to manage traffic, track the origin of customers in shopping centres, or even monitor consumer behaviour through app usage.

Conclusions:

If we do not want this information to be accessible to our competitors:

- It should not be left in the hands of third parties.
- Closed contracts (NDA) should be signed with manufacturers.

At LoxamHune, the solution has been to develop our own devices (both hardware and software).

We have also created the necessary dashboards (Power BI) to make this information available to both technicians and customers!
